- COPY OF LICENSE FOR CERTIFIED NJ LANDSCAPE IRRIGATION CONTRACTOR
- PROOF OF WORKING AUTOMATIC RAIN SENSOR DEVICE PROGRAMMED TO THE IRRIGATION CONTROLLER. (PHOTOGRAPH OF SENSOR, COPY OF INSTALLATION RECEIPT)

PERMIT CONDITIONS

- *UNRESTRICTED SMART IRRIGATION ONLY DURING THE HOURS OF 12 MIDNIGHT TO 10:00 AM.*
- THE INITIAL PROGRAM MUST BE SET BY A CERTIFIED NEW JERSEY LANDSCAPE IRRIGATION CONTRACTOR AND MUST INCLUDE PROPER SPRINKLER HEAD DATA; ACCURATE SOIL, PLANT AND IRRIGATION DATA.
- AFTER INITIAL PROGRAMMING THE CONTRACTOR MUST MAKE A MINIMUM OF TWO SITE VISITS TO ADJUST/FINE TUNE THE IRRIGATION SYSTEM; ONE OF WHICH MUST BE WITHIN THE FIRST TWO WEEKS OF INSTALLATION. ONE OF THE SITE VISITS OR THE INITIAL PROGRAMMING SHOULD BE PERFORMED BY A USEPA WATERSENSE PARTNER.
